## Road Safety Act 1986

### ROAD SAFETY (VEHICLES) REGULATIONS 1999

#### Class 2 Notice –

#### Specification of Routes for B-doubles, Longer B-doubles, Controlled Access Buses and Vehicles Built to Carry Other Vehicles

**1. Purpose**

To specify highways and routes that certain Class 2 vehicles may travel in or on.

**2. Authorising provision**

This Notice is made under Clauses 11, 37 and 42 of Schedule 2 and Regulation 510 of the Road Safety (Vehicles) Regulations 1999.

**3. Commencement**

This Notice comes into operation on 12.00 am Saturday 3 May 2008.

**4. Expiration**

This Notice expires on 11.59 pm Saturday 3 May 2008.

**5. Interpretation**

- (1) In this Notice, unless the contrary intention appears, expressions used have the same meaning as in the **Road Safety Act 1986** and the Road Safety (Vehicles) Regulations 1999.
- (2) For the avoidance of doubt, it is declared that nothing in this Notice is intended to authorise the driving of a vehicle in a manner or in a condition or place that is contrary to any law.

**6. Declaration**

By this Notice, the Roads Corporation specifies –

- Hawthorn Lane between Great Alpine Road (Harrietteville Avenue) and Coronation Avenue in Bright;
- Coronation Avenue between Hawthorn Lane and Deacon Avenue in Bright;
- Deacon Avenue between Coronation Avenue and Cobden Street in Bright;
- Cobden Street between Deacon Avenue and Ireland Street in Bright;
- Railway Avenue between Ireland Street and Station Street in Bright; and
- Station Street in Bright;

as routes that

- B-doubles for the purpose of Clause 11;
- Longer B-doubles for the purpose of regulation 510;
- Controlled Access Buses for the purpose of Clause 37; and
- Vehicles that are over 4.3 metres high, over 19.0 metres long and built to carry other vehicles for the purpose of Clause 42;

may travel in or on.
