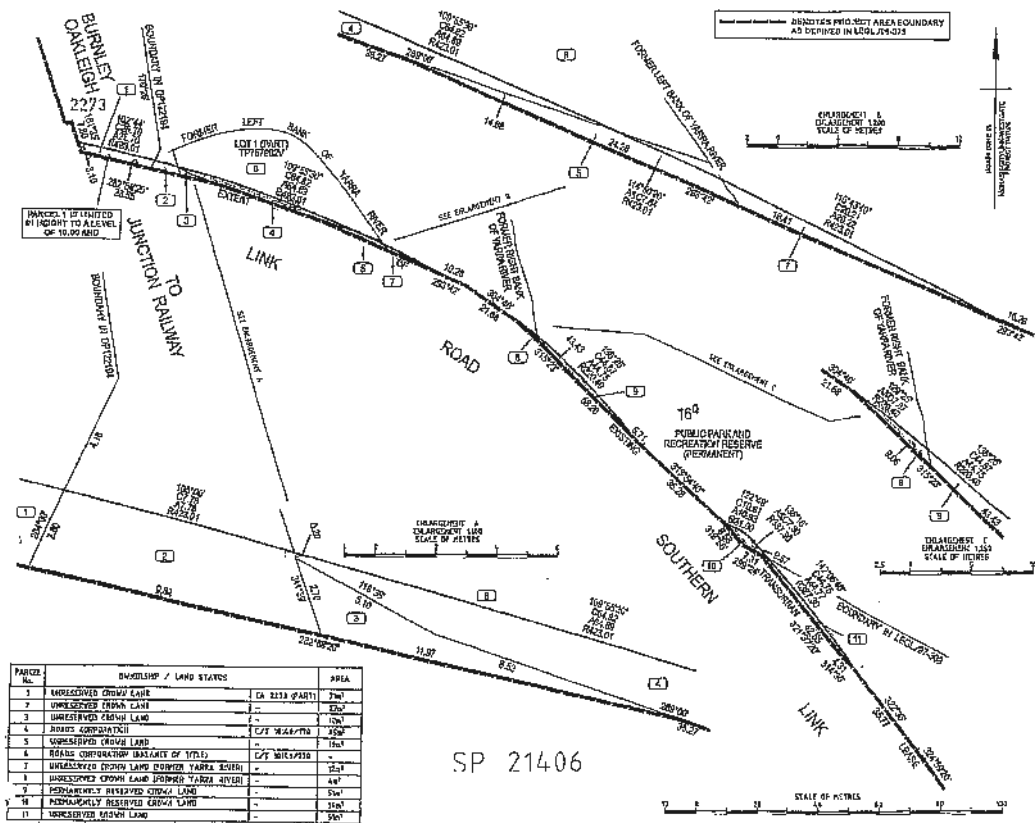
Road Management Act 2004

ORDER PURSUANT TO CLAUSES 26(1)(A) AND 28 OF SCHEDULE 5A

Order in Council

The Lieutenant-Governor, as the Governor's Deputy, with the advice of the Executive Council, under clause 26(1)(a) of Schedule 5A to the **Road Management Act 2004** (the Act), requires the Roads Corporation to surrender to the Crown the land located in the Redevelopment Project area and as identified as Parcel 4 in the attached Survey Plan SP 21406 as noted in Certificate of Title, Vol 10140 Fol 440.

Pursuant to clause 28(5) of Schedule 5A to the Act, this Order has the effect of reserving the Subject Land for the purposes of the Link Upgrade Project.
