DETERMINATION OF FEE

Issue of Hire Car and Special Purpose Vehicle Licences in respect of limousine type vehicles with seating capacity greater than 12 people including the driver

I, Lynne Kosky MP, Minister for Public Transport, under section 142(3) of the **Transport Act 1983**, determine that the fee specified in the table below must be paid for a commercial passenger vehicle licence granted under section 142 of the **Transport Act 1983** between 21 May 2008 and 31 August 2008 where –

- (a) the commercial passenger vehicle is a limousine type vehicle which –
- (i) has a seating capacity of more than 12 people including the driver; and
 - (ii) is based on or derived from a motor vehicle defined under the Australian Design Rules (ADRs) as a –
 - Passenger Car (MA);
 - Forward-Control Passenger Vehicle (MB);
 - Off-Road Passenger Vehicle (MC); and
- (b) immediately prior to the date of this gazette notice, the vehicle –
- (i) has been operated by a person who is accredited to provide tour and charter services under the provisions of the **Public Transport Competition Act 1995**; or
 - (ii) is proposed to be operated by a person who satisfies the licensing authority that the person has made substantial progress towards obtaining accreditation to provide tour and charter services under the provisions of the **Public Transport Competition Act 1995** by applying for accreditation and by providing –
 - evidence that the person owns or is legally committed to purchasing a limousine type vehicle of the kind described in paragraph (a); and
 - evidence of enrolment in the Transport Management Course in Bus and Coach Operations at Monash University.
