### NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT (RIS)

#### Births, Deaths and Marriages Registration Regulations 2008

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the Births, Deaths and Marriages Registration Regulations 2008.

The objective of the proposed Regulations is to renew the existing Births, Deaths and Marriages Registration Regulations 1997 which will expire in September 2008. The proposed Regulations prescribe:

- (a) fees to be paid for some Registry services; and
- (b) the particulars which are to be included in birth registration statements, notices of death and notices in relation to disposal of human remains.

The proposed Regulations require the provision of information to enable births and deaths to be registered and the calculation of base fees on the principle of cost recovery.

The RIS examines the costs and benefits of the proposed Regulations and assesses alternatives to these. The RIS concludes that the proposed Regulations are the most appropriate and beneficial of the considered options.

Public submissions on the proposed Regulations and the RIS are invited. All comments must be submitted in writing by 5pm Tuesday 16 September 2008 as detailed in the RIS.
