## Water Act 1989

### SECTION 87

#### First Mildura Irrigation Trust and Lower Murray Urban and Rural Water Corporation Restructuring Determination

Under the powers in Part 6 and in Schedule 2 of the **Water Act 1989** (the Act), I make the following determination, with the approval of the Treasurer, and specify the following matters –

#### **Restructuring Determination and Specification**

1. Lower Murray Urban and Rural Water Corporation is appointed to take over the whole of the functions, powers and duties of First Mildura Irrigation Trust under the Act, including its functions in respect of all of its districts under the Act.
2. All of the rights, property and assets of First Mildura Irrigation Trust are specified for the purposes of clause 3(a) of Schedule 2 of the Act.

#### **Reasons**

3. In accordance with section 87(2) of the Act, I have –
  - (a) given the reasons for this Determination to First Mildura Irrigation Trust and Lower Murray Urban and Rural Water Corporation, being the water corporations affected by the Determination.
  - (b) laid a copy of the reasons for this Determination before both Houses of the Parliament.

#### **Date of Effect**

4. This Determination and this Specification takes effect on the day after the day on which they are published in the Government Gazette.
