REVOCATION OF AND PROCLAMATION OF APPROVED MENTAL HEALTH SERVICES AT BAYSIDE HEALTH (TO BE KNOWN AS ALFRED HEALTH)

I, David De Kretser, Governor of Victoria, with the advice of the Executive Council and under section 94(1) of the **Mental Health Act 1986** ('the Act'):

- a) **revoke** the proclamations made by the Governor in Council under section 94(1) of the Act on 28 June 2000, and published in Government Gazette S96 on 30 June 2000, which proclaimed:
 - (i) the Alfred Hospital campus of Bayside Health situated at Commercial Road, Prahran 3181 known as 'Alfred Psychiatry – The Alfred – Inner South East Area Mental Health Service', as an approved mental health service; and
 - (ii) the Caulfield General Medical Centre campus of Bayside Health situated at 260–294 Kooyong Road, Caulfield 3162, known as 'Caulfield Aged Psychiatry Service', as an approved mental health service;
- b) **proclaim** The Alfred campus of Alfred Health situated at Commercial Road, Melbourne, 3004, to be an approved mental health service known as 'Alfred Psychiatry'; and
- c) **proclaim** the Caulfield General Medical Centre campus of Alfred Health situated at 260–294 Kooyong Road, Caulfield, 3162, to be an approved mental health service known as 'Caulfield Aged Psychiatry Service'.

The proclamation will take effect from the day after it is made.
