Notice of Preparation of Amendment

Amendment C61

Authorisation A01069

The Bass Coast Shire Council has prepared Amendment C61 to the Bass Coast Planning Scheme.

In accordance with section 9(2) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Bass Coast Shire Council as planning authority to prepare the Amendment.

The land affected by the Amendment is:

- Properties on the eastern side of Bass Highway, between Bass Road (south of Bass township) and Woolamai Road
- Properties on both sides of the Bass Highway, between Woolamai Road/Bass Landing Road and Coast Road
- Properties from the intersection of Bass Highway/Coast Road to Phillip Island Road approximately 1.5 kilometre west of Bass Highway from the Anderson roundabout and 5 kilometres east of San Remo.

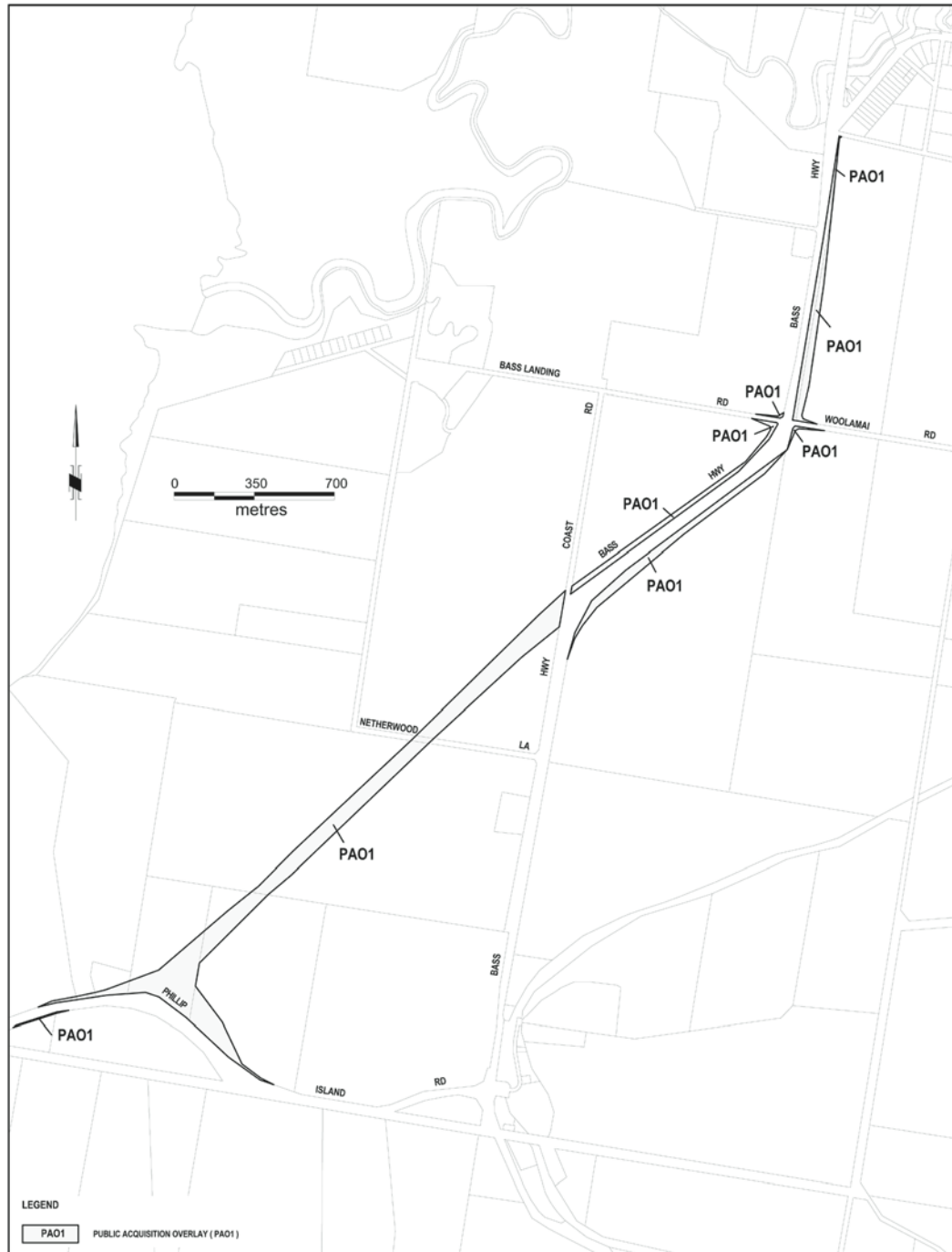
The Amendment proposes to rezone land to Public Acquisition Overlay (PAO) in response to Stage 7 of the Bass Highway Upgrade project. The Amendment will also amend Clauses in the Bass Coast Planning Scheme.

You may inspect the Amendment, any documents that support the Amendment and the explanatory report about the Amendment at the following locations: at the office of the planning authority, Bass Coast Shire Council, free of charge during office hours; and at the Department of Planning and Community Development website www.dpcd.vic.gov.au/planning/publicinspection

Any person who may be affected by the Amendment may make a submission to the planning authority.

The closing date for submissions is 27 October 2008. A written submission must be sent to the Bass Coast Shire Council.
