FISHERIES (RECREATIONAL ABALONE FISHING DAYS) NOTICE NO. 8/2009

1. Title

This Notice may be cited as the Fisheries (Recreational Abalone Fishing Days) Notice No. 8/2009.

2. Objectives

The objective of this Notice is to specify 60 days during the 12 month period from 1 October 2009 when recreational fishing for abalone will be permitted in central Victorian waters (as defined in regulation 237(1) of the Fisheries Regulations 2009).

Note:

In the definitions of the Fisheries Regulations 2009 'central Victorian waters' means the marine waters between longitude 143° 27' 36" East (mouth of the Aire River near Cape Otway) and 145° 53' 35" East, 38° 50' 19" South (north-western part of Arch Rock in Venus Bay) where the eastern boundary is a line running due west from the most north-western part of Arch Rock to the seaward limit of State waters.

3. Authorising Provision

This Notice is made under section 152(1)(b) of the **Fisheries Act 1995**.

4. Commencement

This Notice comes into operation on 1 October 2009.

5. Permitted Recreational Abalone Fishing Days

Despite the abalone closed season specified in the Table in regulation 237(1) of the Fisheries Regulations 2009 recreational abalone fishing will be permitted in central Victorian waters on the following days:-

21 and 22 November 2009 inclusive (2 days)

28 and 29 November 2009 inclusive (2 days)

5 and 6 December 2009 inclusive (2 days)

12 and 13 December 2009 inclusive (2 days)

19 and 20 December 2009 inclusive (2 days)

24 December 2009 to 3 January 2010 (11 days)

9 and 10 January 2010 inclusive (2 days)

16 and 17 January 2010 inclusive (2 days)

23 to 24 January 2010 inclusive (2 days)

26 January 2010 (1 day)
30 and 31 January 2010 inclusive (2 days)
6 and 7 February 2010 inclusive (2 days)
13 and 14 February 2010 inclusive (2 days)
20 and 21 February 2010 inclusive (2 days)
27 and 28 February 2010 inclusive (2 days)
6 March 2010 to 8 March 2010 inclusive (3 days)
