## Marine Act 1988

### SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Inspector Stephen Guilmartin, a member of Victoria Water Police, hereby:

1. Give notice under subsection 15(2) of the **Marine Act 1988**, that from 0500 hours on Saturday 3 October 2009 till 2359 hours on 31 October 2009 bathing and the operation of vessels (including anchoring, mooring, drifting or allowing a vessel to lie) except those vessels authorised by Marine Safety Victoria is prohibited within the exclusion zones as detailed in **Table 1**.

**Table 1**

**Towing Phase Exclusion Zone:** An exclusion zone applies within of 500 metres of any towing vessel, towing lines, assisting tugs and the ex HMAS Canberra during the tow from Geelong Harbour (and proceeding through the Hopetoun Channel, William Spit Channel and Point Richards Channel, then via the South Channel and through Port Phillip Heads) to a location 2 nm South of Ocean Grove, Victoria, in the approximate position Lat 38°17' 55.7395" S Long 144° 32' 36.7839" E.

**Scuttling Phase Exclusion Zone:** An exclusion zone applies, within the waters bounded by the following positions:

**Post Scuttling Phase Exclusion Zone:** An exclusion zone applies within 200 metres of the scuttled ex HMAS Canberra in the approximate position Lat 38°17' 55.7395" S Long 144° 32' 36.7839" E as indicated by a yellow buoy with the light characteristics Q.Fl.Y.
