- 57/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 September 2010, it comes into operation on that day.
- 58/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 September 2012, it comes into operation on that day.
- 59/2009 (1) Sections 1 and 31 and this section come into operation on the day on which this Act receives the Royal Assent.
 (2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
 (3) If a provision referred to in subsection (2) does not come into operation before 1 July 2011, it comes into operation on that day.
- 60/2009 (1) Subject to subsection (2), this Act comes into operation on the day on which it receives the Royal Assent.
 (2) Sections 6(2), 6(3) and 6(4) come into operation on a day or days to be proclaimed.
