NOTICE OF DECISION TO MAKE PROPOSED STATUTORY RULE

Liquor Control Reform Regulations 2009

Notice is given in accordance with section 12 of the **Subordinate Legislation Act 1994** of a decision to make the proposed Liquor Control Reform Regulations 2009.

A Regulatory Impact Statement (RIS) for the proposed regulations was released for public comment on 12 August 2009, and submissions were accepted until 18 September 2009.

A total of 39 submissions were received and they have been considered.

I have decided to recommend that the proposed regulations should be made with the following amendments to the draft regulations which accompanied the RIS:

- the venue capacity multiplier will only apply to licensed premises with more than 200 patrons, with the multiplier increasing by 0.25 for every additional 100 patrons up to a maximum multiplier of 4 for 1,301 or more patrons
- the venue capacity multiplier will not apply to the 11.01 pm to 1.00 am operating hours risk fee unless one or more non-compliance incidents relate to the licence in the relevant period
- a separate fee structure will apply to licences on which a condition is specified regarding the provision of sexually explicit entertainment
- the maximum patron numbers specified on a licence for areas within licensed premises that are used to provide accommodation may be excluded from the calculation of total venue capacity
- the maximum patron numbers specified on a licence for function areas within licensed premises may be excluded from the calculation of total venue capacity if certain requirements are satisfied.
