SECTION 15 NOTICE

I, Lisa Faldon, the Director of Marine Safety, on the recommendation of Wayne Hill, Acting Manager Operations, Bays & Maritime Division, Parks Victoria (the Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip) hereby give notice under section 15(1) of the **Marine Act 1988**, that:

1. from 1.00 am Saturday 31 October 2009 till 1.00 am Sunday 28 February 2010, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels owned and operated by Parks Victoria and vessels associated with the Melbourne Main Sewer Replacement Project are prohibited on all the waters of the Yarra River as detailed below in Table 1:

Table 1: Yarra River Exclusion Zone

The waters bounded by:

- (i) A line extending from a yellow buoy in approximate position 37°49' 25.4175 S, 144° 56' 50.2535 E; to a yellow buoy in approximate position 37° 49' 24.1548 S, 144° 56' 50.3058 E;
- (ii) A line extending from a yellow buoy in approximate position 37° 49' 24.1548 S, 144° 56' 50.3058 E; to a point on the Charles Grimes Bridge at 37° 49' 24.5875 S, 144° 56' 53.8464 E;
- (iii) A line extending from a point on the Charles Grimes Bridge at 37° 49' 24.5875 S, 144° 56' 53.8464 E; to a yellow buoy in approximate position 37° 49' 25.1405 S, 144° 56' 58.3714 E;
- (iv) A line extending from a yellow buoy in approximate position 37° 49' 25.1405 S, 144° 56' 58.3714 E; to a yellow buoy in approximate position 37° 49' 25.9416 S, 144° 56' 58.2158 E;
- (v) A line extending from a yellow buoy located in approximate position 37° 49' 25.9416 S, 144° 56' 58.2158 E; to a yellow buoy in approximate position 37° 49' 25.4175 S, 144° 56' 50.2535 E

2. at the completion of the works on Sunday 28 February 2010 the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
