## Road Management Act 2004

### SPECIFYING ALPINE RESORT MANAGEMENT BOARDS UNDER SECTION 37(1)(b)(viii) OF THE ROAD MANAGEMENT ACT 2004

I, Tim Pallas MP, Minister for Roads and Ports, under sub-section 37(1)(b)(viii) of the **Road Management Act 2004**, having consulted the Minister for Environment and Climate Change, declare that the Alpine Resort Management Boards, as established under the **Alpine Resorts (Management) Act 1997** and listed in Column 1 in the Schedule below, are the specified persons or bodies for the purposes of sub-section 37(1)(b)(ii) to (vi) inclusive for the relevant sections of the specified arterial roads, as declared by VicRoads under the **Road Management Act 2004** and listed in Column 2 where those arterial roads are located within the boundaries of the Alpine Resorts listed in Column 3. This declaration may be varied by arrangements made between VicRoads and the relevant Alpine Resort Management Board under section 15 of the **Road Management Act 2004**.
