## Major Sporting Events Act 2009

### MAJOR SPORTING EVENT ORDER – 2009 AUSTRALIAN MASTERS GOLF TOURNAMENT

#### Order in Council

The Governor in Council under section 7 of the **Major Sporting Events Act 2009** makes a major sporting event order in relation to the 2009 Australian Masters Golf Tournament, as follows:

<b>Event:</b>	<b>2009 Australian Masters Golf Tournament</b>
Event venue:	The area bounded by the yellow line on LEGL./09–395
Aerial advertising event:	2009 Australian Masters Golf Tournament
Aerial advertising venue:	The area bounded by the yellow line on LEGL./09–395
Event area:	The area hatched red on the plan LEGL./09–395
Event organiser:	IMG, ABN 23 001 788 343
Date when the order applies:	11, 12, 13, 14, and 15 November 2009
Aerial advertising limitation period:	From 6.00 am until 8.00 pm on 11, 12, 13, 14, and 15 November 2009
Crowd management period:	From 6.00 am until 11.00 pm on 11, 12, 13, 14, and 15 November 2009
Commercial arrangements period:	From 6.00 am until 11.00 pm on 11, 12, 13, 14, and 15 November 2009
Part of the Act which applies:	Part 8 (aerial advertising) applies to the event venue and event area but is limited to exclude aircraft which may be visible from the event venue and event area when taking off or landing at Moorabbin airport in order to travel to other locations to provide aerial advertising services. Section 37 (Part 3) applies to the event area. Section 62 (Part 4) applies to the event area, but only in relation to section 3 paragraph (m) in the definition of ‘prohibited item’ which provides that “any items which are in such a quantity that a reasonable person could infer that those items are to be used for commercial purposes”.

This Order comes into effect from the date it is published in the Government Gazette.
