WILDLIFE (CONTROL OF GAME HUNTING) NOTICE NO. 3/2009

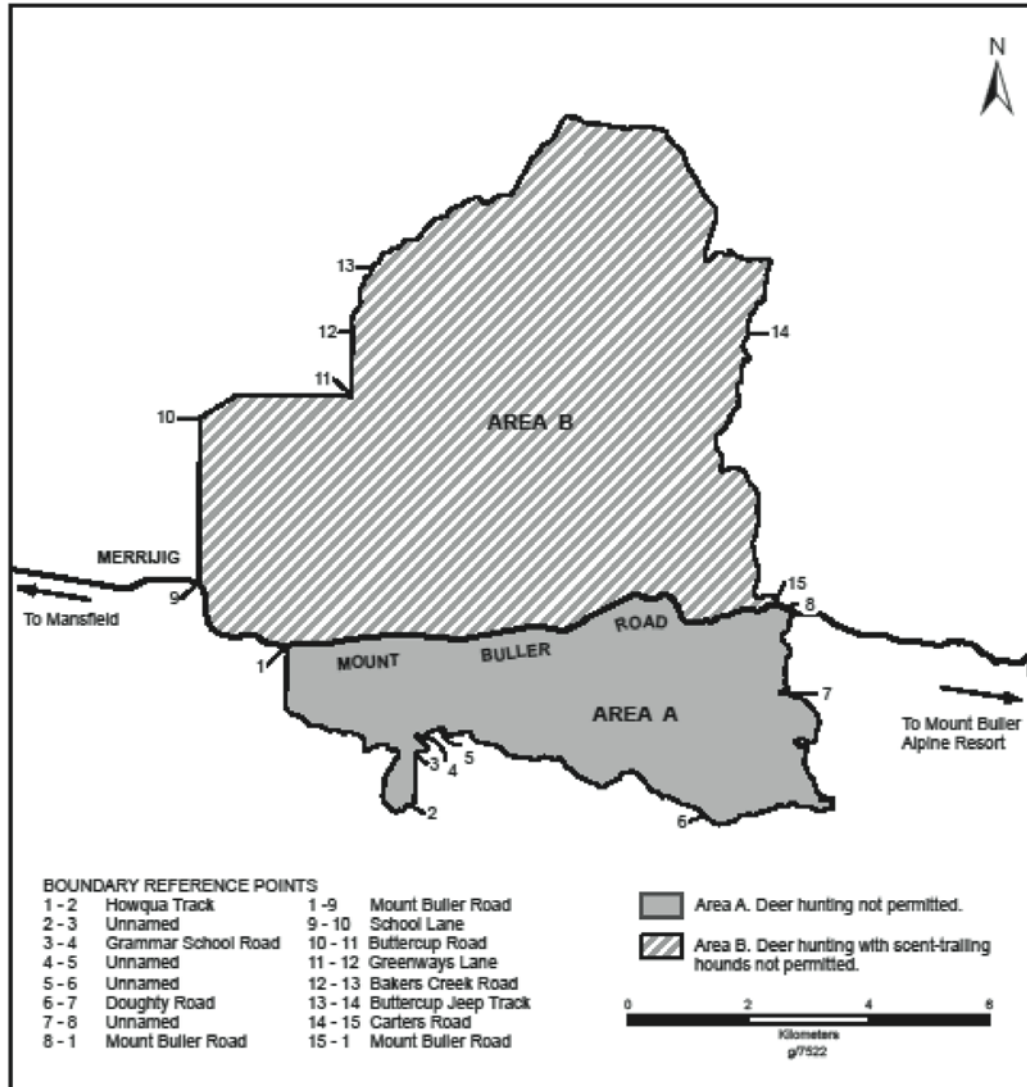
I, Gavin Jennings, Minister for Environment and Climate Change, make the following Notice:

- 1. Objective**
The objective of this Notice is to prohibit deer hunting in specified areas by specified methods for the period of the Notice.
- 2. Authorising provision**
This Notice is made under section 86 of the **Wildlife Act 1975**.
- 3. Commencement**
This Notice comes into operation on the date on which it is published in the Government Gazette and expires on 19 October 2010.
- 4. Definitions**
Deer means any kind or taxon of deer declared to be game for the purposes of the **Wildlife Act 1975**.
Scent-trailing hound has the same meaning as in the Wildlife (Game) Regulations 2001.
- 5. Hunting of deer in certain areas prohibited**
The holder of a game licence endorsed for deer must not take, destroy or hunt deer in the area in Schedule 1 indicated by shading and described as Area A.
- 6. Hunting of deer with scent-trailing hounds in certain areas prohibited**
The taking, destroying or hunting of deer with scent-trailing hounds in the area in Schedule 1 indicated by diagonal lines and described as Area B is prohibited.
- 7. Contravention of Notice**
A person must not contravene any part of this Notice.
Penalty: 25 penalty units.
