Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Wayne Hill, Acting Manager, Marine Operations, Bays and Maritime, Parks Victoria (Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip), hereby give notice under subsection 15(1) of the **Marine Act 1988** of the following temporary amendments to Schedule 3, contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**, that:

- (a) between the hours of 10.00 am on Saturday 28 November 2009 and 4.00 pm on Saturday 28 November 2009, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the Head of the Yarra Rowing Regatta and vessels owned and operated by Parks Victoria, is prohibited on the waters of the Yarra River between –
 - an imaginary line at the downstream edge of the VRA Landing to the upstream edge of Federation Wharf, and
 - upstream to the Victoria Road Bridge
- (b) rowing vessels involved in the Head of the Yarra Rowing Regatta event are excluded from the requirement to wear personal flotation devices as detailed in Schedule 5, made under Regulation 232 of the Marine Regulations 1999;
- (c) vessels involved in the Head of the Yarra Rowing Regatta event are excluded from the requirement to operate a vessel at a speed not exceeding 5 knots; within 50 meters of the waters edge as detailed in clause 3(a) of Notice No. 1 under section 15(2) of the **Marine Act 1988**.

At the completion of the event the waters of the Yarra River will revert to the normal provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
