ERRATUM

The notice published in the Victoria Government Gazette No. S 425 was inadvertently published on 26 November 2009. The correct notice is reproduced below.

Road Safety Act 1986

EXEMPTION OF PERSONS PARTICIPATING IN THE VALVOLINE SPRING CAR NATIONALS AUTOFEST AT THE SHEPPARTON SHOWGROUNDS

1. Purpose

The purpose of this notice is to exempt persons from section 65A(1) of the **Road Safety Act 1986**, while participating in the Valvoline Spring Car Nationals Autofest from 27 to 29 November 2009 at the Shepparton Showgrounds.

2. Authorising provision

This notice is made under section 65A(3) of the **Road Safety Act 1986**.

Subsection 65A(1) of the **Road Safety Act 1986** provides that a person must not drive a motor vehicle in a manner which causes the motor vehicle to undergo loss of traction by one or more of the motor vehicle's wheels. (Penalty: 5 penalty units)

Subsection 65A(3) of the **Road Safety Act 1986** empowers the Minister to declare, by notice published in the Government Gazette, that subsection (1) does not apply to persons while participating in –

- (a) a function or event, or a type of function or event, specified in the declaration and conducted on land specified in the declaration; or
- (b) an event or function at a motor sport venue specified in the declaration.

3. Commencement

This notice comes into operation on 27 November 2009.

4. Expiry

This notice expires at midnight on 29 November 2009.

5. Declaration

For the purposes of section 65A(3) of the **Road Safety Act 1986**, I, Tim Pallas, Minister for Roads and Ports, declare that section 65A(1) of the **Road Safety Act 1986** does not apply to a person while participating in the Valvoline Spring Car Nationals Autofest, being held from 27 to 29 November 2009, provided that –

- (a) the person is inside the physical boundary of the Shepparton Showgrounds; and
- (b) all safety and other requirements, as determined by the event organiser, are complied with.
