NOTICE OF DECISION

Births, Deaths and Marriages Registration Amendment Regulations 2009

I, Rob Hulls, MP, Attorney-General and Minister responsible for administering the **Births, Deaths and Marriages Registration Act 1996**, give notice under section 12 of the **Subordinate Legislation Act 1994** as follows:

The Births, Deaths and Marriages Registration Amendment Regulations 2009 have been prepared to accommodate changes made to the **Births, Deaths and Marriages Registration Act 1996** by the **Coroners Act 2008**, the **Relationships Act 2008** and the **Assisted Reproductive Treatment Act 2008**.

These Regulations amend the Births, Deaths and Marriages Registration Amendment Regulations 2008 and their effect is to:

1. Insert a definition for a 'registered relationship', 'donor treatment procedure' and 'registered ART provider';
2. Specify the information to be included in a birth registration statement;
3. Specify the information to be provided by doctors in death notifications;
4. Specify the information to be provided by funeral directors or other responsible persons for death notifications.

An exemption from the requirement to undertake a Regulatory Impact Statement was approved on the basis that these changes do not impose an appreciable economic or social burden on any sector of the community.

I now give notice of my intention to proceed with the making of the proposed Regulations.
