- 84/2009 (1) This Act (other than Part 2) comes into operation on the day after the day on which it receives the Royal Assent.  
(2) Part 2 comes into operation on 1 July 2012.
- 85/2009 This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 86/2009 This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 87/2009 (1) This Part, Part 2 (except sections 3, 4 and 5), Part 3 (except sections 8 and 10), Part 4 and Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Sections 8 and 10 come into operation on a day to be proclaimed.  
(3) If sections 8 and 10 do not come into operation before 1 February 2010, they come into operation on that day.  
(4) Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.  
(5) If a provision referred to in subsection (4) does not come into operation before 1 November 2010, it comes into operation on that day.
- 88/2009 (1) Sections 1 and 5 and this section come into operation on the day after the day on which this Act receives the Royal Assent.  
(2) Section 9 comes into operation on the day on which section 11 of the **Infringements and Other Acts Amendment Act 2008** comes into operation.
