## SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Wayne Hill, Acting Manager, Operations, Bays and Maritime, Parks Victoria (the Waterway Manager for The Designated Port of Port Phillip) hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- (a) from 8.15 pm Saturday 5 December 2009 till 10.30 pm Saturday 5 December 2009, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria, is prohibited within 200 metres of the fireworks barge located approximately 300 metres offshore from The Royal Geelong Yacht Club.
- (b) the fireworks barge is located in the approximate position 38° 08.499' S, 144° 22.015' E (WGS84).

## SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Darren Schultz, Building and Contracts Officer, Loddon Shire Council, (Waterway Manager for the Loddon River At Bridgewater between Flour Mill Weir and Sweeneys Lane) hereby give notice under subsection 15(1) of the **Marine Act 1988**, that:

1. From 5.00 pm Friday 4 December 2009 till 5.00 pm Sunday 6 December 2009, the waters of the Loddon River at Bridgewater, between the Flour Mill Weir and Sweeneys Lane:
  - (a) are subject to a speed restriction of 5 knots for the purposes of conducting the Loddon Classic Fishing Competition;
  - (b) the provisions as specified in Clause 5 of Schedule 62 of Notice No. 1 under section 15(2) of the **Marine Act 1988** do not apply for the duration of the Loddon Classic Fishing Competition.
2. At the completion of the event the waters will revert to the provisions of Schedule 62 contained in Notice No. 1 under subsection 15(2) of the **Marine Act 1988**.
