Amendment C110

The Minister for Planning has approved Amendment C110 to the Boroondara Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment extends the expiration date of Schedule 8 to the Design and Development Overlay (DDO8) where it applies to Burwood Village, and Schedule 9 (DDO9) where it applies to Ashburton and Hartwell, by 3 months to 31 March 2010.

Amendment C135

The Minister for Planning has approved Amendment C135 to the Cardinia Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment amends:

- the Schedule to Clause 52.17 of the Cardinia Planning Scheme to allow native vegetation in the Cardinia Reservoir Park, Emerald, to be removed, destroyed or lopped without the need for a permit, to enable the land to

be developed by or on behalf of Melbourne Water for the Desalinated Water Integration Project (the Project);

- the Schedule to Clause 61.01 of the Cardinia Planning Scheme to make the Minister for Planning the responsible authority for administering and enforcing Clause 52.17 of the Planning Scheme in relation to the removal, destruction and lopping of native vegetation for the Project.
