#### ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares or revokes the roads described in Schedule A and on the plans attached.

#### ROAD DISCONTINUATION

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the road or part of the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 47 of the **Transport Act 1983** and as delegated by the Minister for Roads and Ports under section 32 of the latter said Act.

### SCHEDULE A

- a) That part of Metropolitan Ring Road identified by hatching on the plan numbered GP21371 is declared as described in the legend in the said plan.

#### ARTERIAL ROAD

- b) Those parts of Cranbourne–Narre Warren Road identified by hatching on the plan numbered GP20034 are declared as described in the legend in the said plan.
- c) That part of Doncaster–Eltham Road identified by hatching on the plan numbered GP19631 is declared as described in the legend in the said plan.
- d) That part of Doncaster Road identified by hatching on the plan numbered GP21760 is revoked as described in the legend in the said plan.

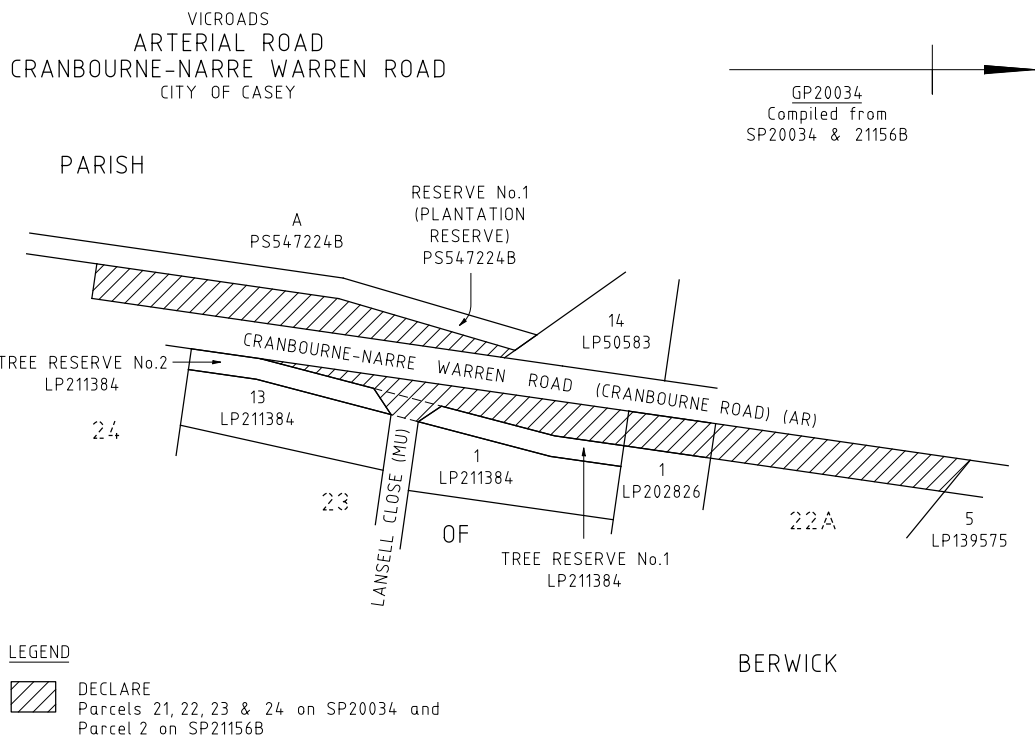
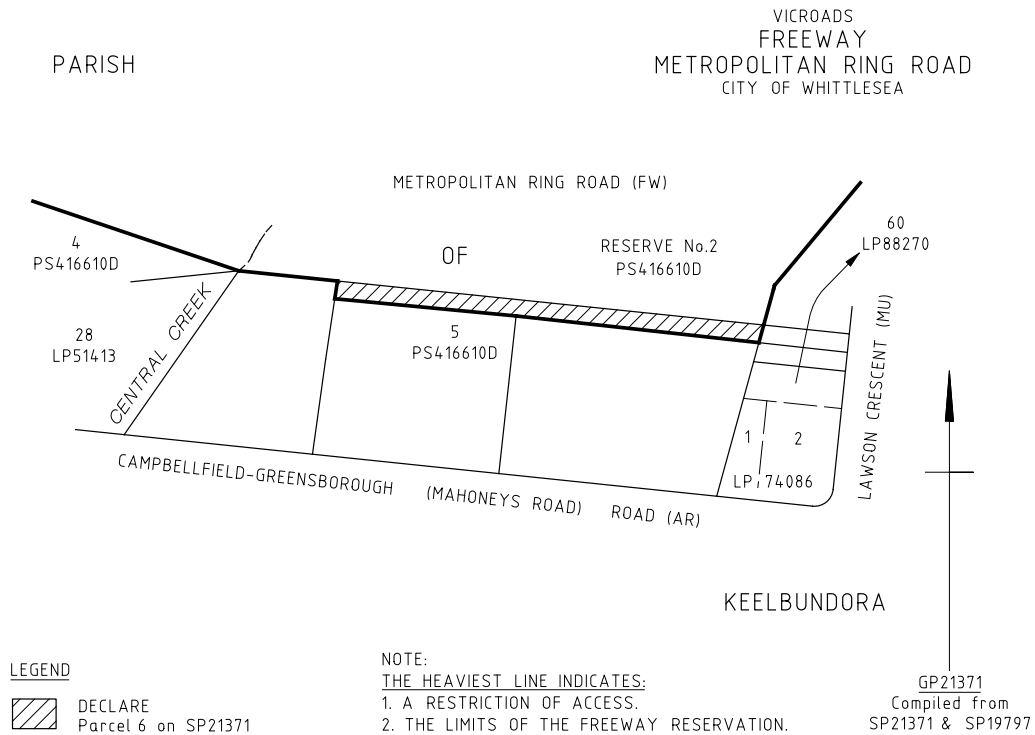

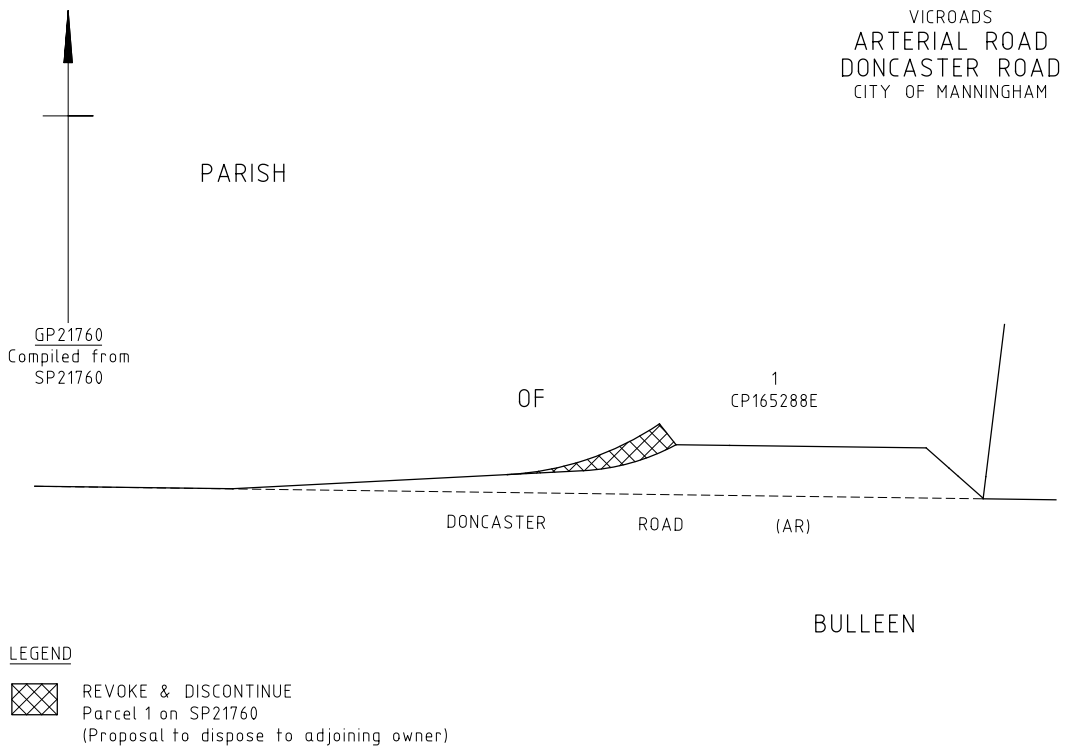
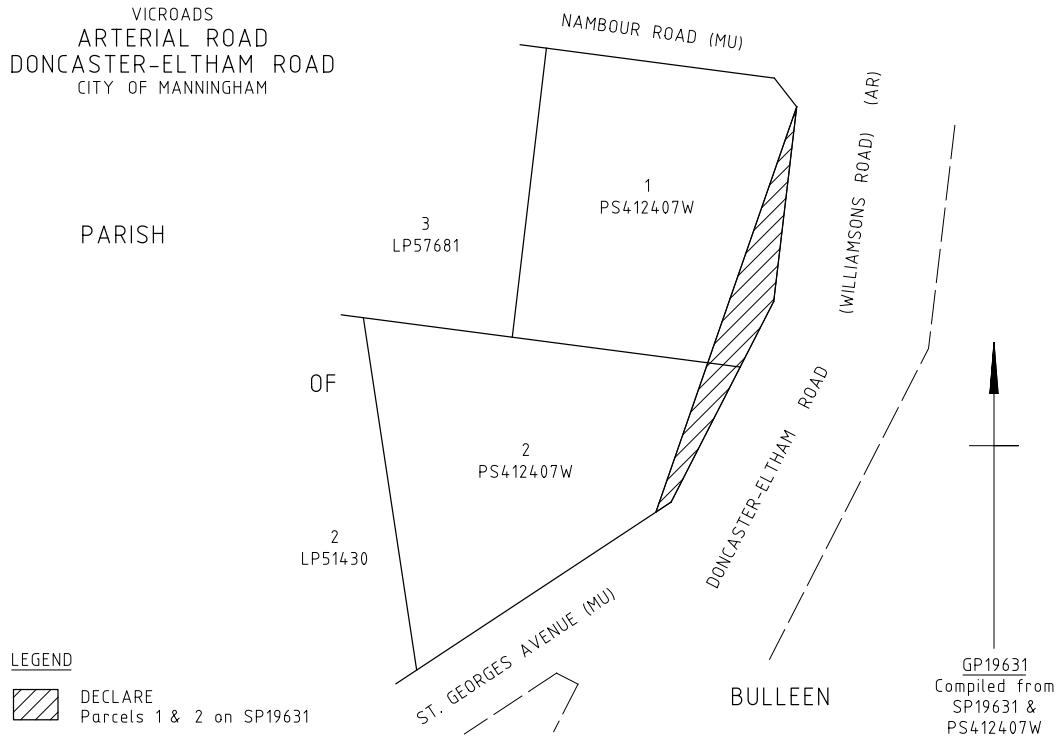
- e) Those parts of Lyppards Road and Kelvin Grove identified by hatching on the plan numbered GP21220 are declared as described in the legend in the said plan.

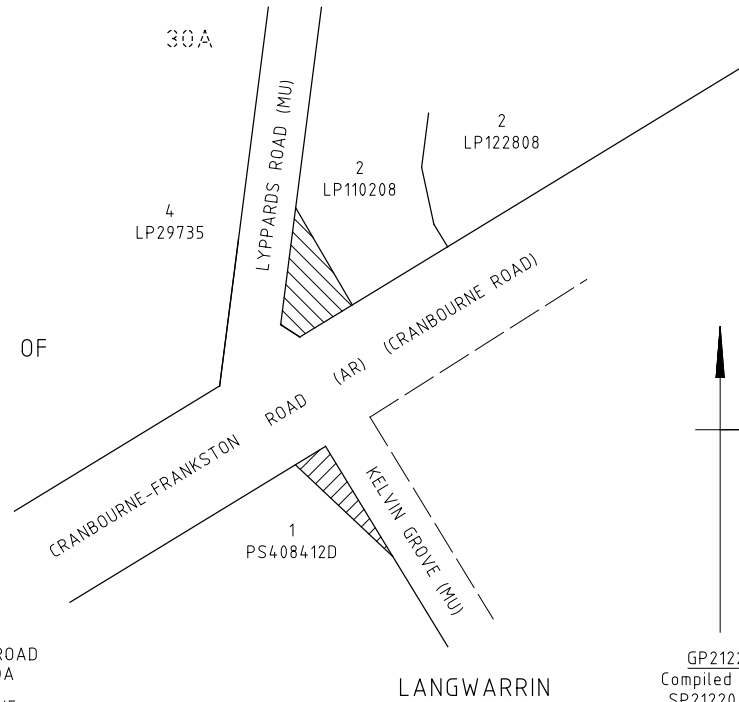
