YARRA RANGES PLANNING SCHEME
Notice of Approval of Amendment
Amendment C105

The Minister for Planning has approved Amendment C105 to the Yarra Ranges Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- changes the Schedule to Clause 61.01 to make the Minister for Planning the Responsible Authority for matters relating to the use and development of land at 12 Ornata Road, Mount Dandenong;
- changes the Schedule to Clause 52.03 Specific Sites and Exclusions to include land at 12 Ornata Road, Mount Dandenong; and
- changes the Document Incorporated under the Schedule to Clause 52.03 Specific Sites and Exclusions of the Yarra Ranges Planning Scheme December 2009.
