- 79/2009 This Act comes into operation on 1 July 2010.
- 80/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 May 2010, it comes into operation on that day.
- 81/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 July 2010, it comes into operation on that day.
- 82/2009 (1) Subject to subsection (2), the provisions of this Act come into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 30 September 2010, it comes into operation on that day.
- 83/2009 (1) This Part and Part 7 come into operation on the day on which this Act receives the Royal Assent.
(2) Part 2 comes into operation on 1 January 2010.
(3) Division 1 of Part 3 is deemed to have come into operation on 1 January 2006.
(4) Division 2 of Part 3 and Divisions 2 and 3 of Part 5 come into operation on the day after the day on which this Act receives the Royal Assent.
(5) Part 4 is deemed to have come into operation on 1 July 2009.
(6) Subject to subsection (7), Division 1 of Part 5 and Part 6 come into operation on a day to be proclaimed.
(7) If a provision referred to in subsection (6) has not come into operation before 1 October 2010, it comes into operation on that day.
