- 1/2009 This Act comes into operation on the day after the day on which it receives the Royal Assent.
 - 2/2009
 - (1) This Act (except sections 6(2), 7, 8, 10 and 11) comes into operation on the day after the day on which it receives the Royal Assent.
 - (2) Subject to subsection (3), sections 6(2), 7, 8, 10 and 11 come into operation on a day or days to be proclaimed.
 - (3) If section 6(2), 7, 8, 10 or 11 does not come into operation before 1 November 2009, it comes into operation on that day.
 - 3/2009
 - (1) This Part and Part 3 come into operation on the day after the day on which this Act receives the Royal Assent.
 - (2) Subject to subsection (3), Part 2 commences on a day or days to be proclaimed.
 - (3) If a provision of Part 2 does not come into operation before 1 February 2010, it comes into operation on that day.
 - 4/2009
 - (1) Subject to subsection (2), this Act (including the items in Schedule 1) comes into operation on a day or days to be proclaimed.
 - (2) If a provision of this Act (including an item or provision of an item in Schedule 1) does not come into operation before 1 December 2009, it comes into operation on that day.
 - 5/2009 This Act comes into operation on the day after the day on which it receives the Royal Assent.
