## Port Services Act 1995

### AMENDMENT TO A DECLARATION OF RESTRICTED ACCESS AREAS IN THE YARRA RIVER AND PORT PHILLIP BAY AROUND VESSELS

I, Tim Pallas, Minister for Roads and Ports make the following declaration:

In accordance with section 87 of the **Port Services Act 1995**, I declare under section 84(1) of the **Port Services Act 1995** the following amendments to the Declaration of Restricted Access Areas in the Yarra River and Port Phillip Bay Around Vessels made under section 84(1) of the **Port Services Act 1995**, dated 28 March 2008 and published in the Victoria Government Gazette No. S 85 on Monday 31 March 2008 (the Declaration), as amended by the Amendment declared on 21 August 2008 and published in the Victoria Government Gazette No. S 233 on 27 August 2008.

- (i) The addition of the Prins der Nederlanden as a specified dredge vessel, by replacing sub-paragraphs A. and B. of both paragraphs 2(i) and (ii) with the following:
  - A. the Queen of the Netherlands dredge vessel; or
  - B. Cornelis Zanen dredge vessel; or
  - C. the Prins der Nederlanden dredge vessel.:
- (ii) The addition of the Prins der Nederlanden dredge vessel as a specified vessel in line 2 of paragraph 3(i), and in sub-paragraphs 3(i)A, 3(i)D, 3(ii)B and 3(iii)B(i).

This declaration takes effect from 12.01 am on Saturday 14 February 2009.
