Marine Act 1988

SECTION 15 NOTICE

I, Brian Riches, the Director of Marine Safety, on the recommendation of Mal Poulter, Acting Manager of Operations, Bays and Maritime Division, Parks Victoria hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- (a) bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie) is prohibited on the waters of the Yarra River within the areas detailed in Table 1, and the times specified in Table 2, excluding those vessels associated with the 2009 Melbourne Moomba Waterfest Set Up and vessels operated by Parks Victoria;
- (b) at the completion of the 2009 Melbourne Moomba Waterfest Set Up on any of the days detailed in Table 2 and as determined and announced by the Parks Victoria Ranger in Charge, Yarra River, the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
