WILDLIFE (CONTROL OF GAME HUNTING) NOTICE NO. 2/2009

I, Gavin Jennings, Minister for Environment and Climate Change, make the following Notice:

- Objective**
The objective of this Notice is to prohibit duck hunting in certain areas for the period of the Notice.
- Authorising provision**
This Notice is made under section 86 of the **Wildlife Act 1975**.
- Commencement**
This Notice comes into operation on the day after it is published in the Government Gazette and expires on 8 May 2009.
- Hunting of ducks prohibited**
The taking, destroying or hunting of any taxa of duck prescribed as a game bird for the purposes of the Wildlife (Game) Regulations 2001 in the areas described in Schedule 1 and Schedule 2 is prohibited.
- Contravention of Notice**
A person must not contravene any part of this Notice.
Penalty: 25 penalty units.

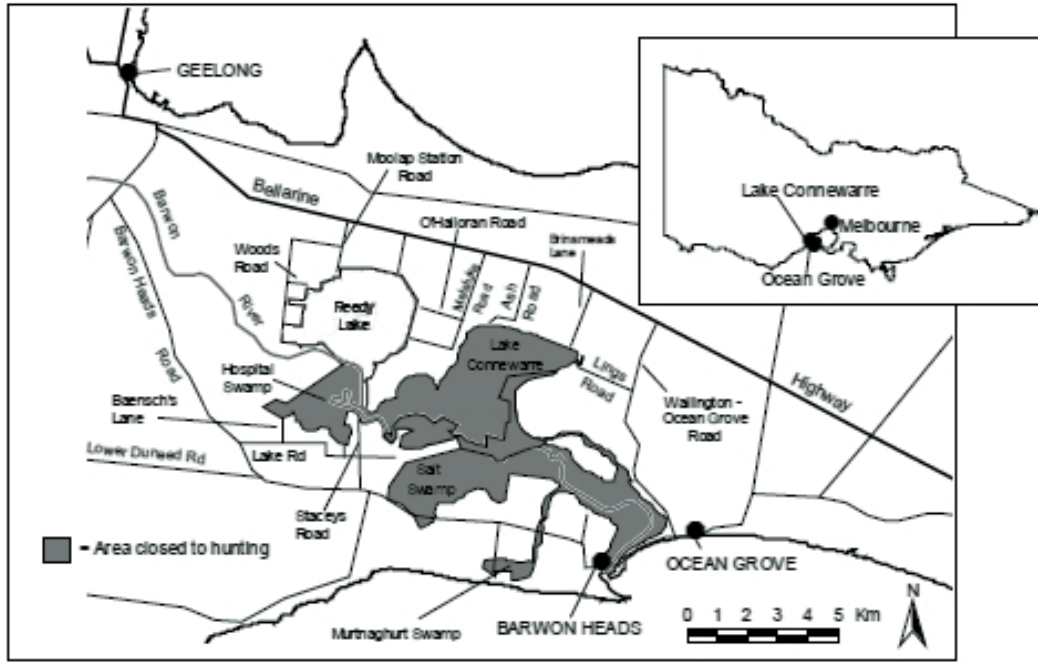
