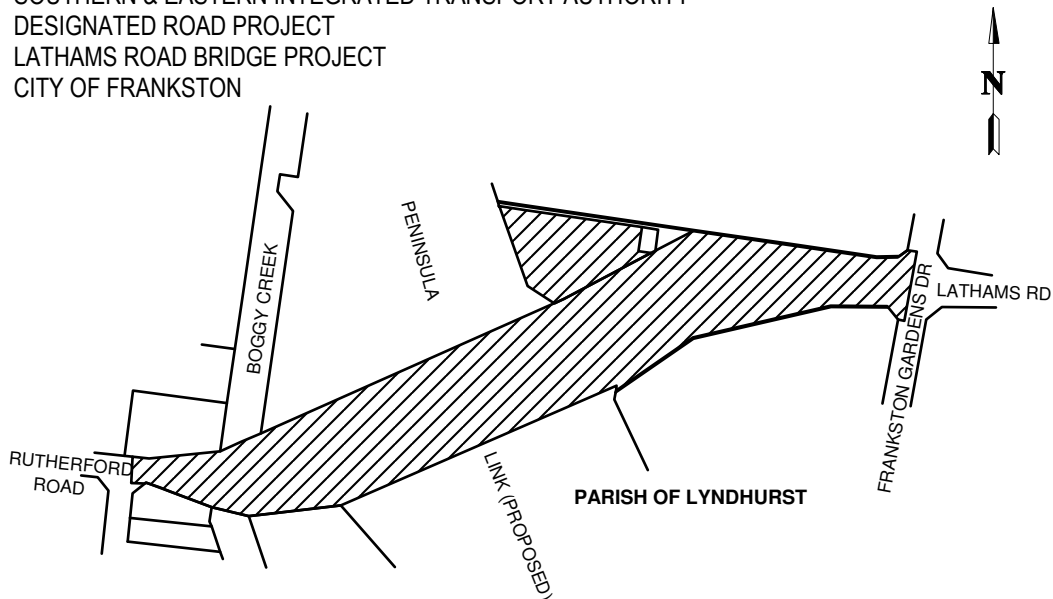
Road Management Act 2004

DETERMINATION OF THE LATHAMS ROAD BRIDGE PROJECT TO BE A DESIGNATED ROAD PROJECT

I, Tim Pallas MP, Minister for Roads and Ports, under section 16 of the **Road Management Act 2004** determine as follows:

- 1 That part of Peninsula Link specified in this determination and known as the Lathams Road Bridge Project is a designated road project.
2. The public authority to which the designated road project is assigned is the Southern and Eastern Integrated Transport Authority.
3. The project area for the purposes of the designated road project is the area within the City of Frankston, comprising the parts of the road reserve shown by hatching and described in the legend on the attached plan numbered GP PL_DP1.
4. The period during which this determination is to remain in force is from 21 April 2009 until 30 June 2013 (including both of those days) or, if this determination is earlier revoked, from 21 April 2009 until the day on which it is revoked (including both of those days).
