ADDENDA TO THE NOTICE CALLING FOR EXPRESSIONS OF INTEREST TO BE INVITED TO APPLY FOR THE MONITORING LICENCE (TENDER NO. 009-09)

This addenda is made pursuant to *Part C, Section 7.1 of the Notice* (Additions and Amendments to Notice) which states:

‘The State reserves the right to change any information in, or to issue addenda to, this Notice. All such addenda will, upon issue, become part of this Notice. The State may also vary the timetables, requirements and any other aspect of or in connection with the EOI Process or the Licensing Process without being obliged to give reasons for doing so.

Notifications of amendments to this Notice on or before the expiration of the Lodgement Period will be notified via publication in the Victorian Government Gazette and a posting on the Victorian Government tenders website: www.tenders.vic.gov.au.’

The State, by issuing this Addenda to the Notice calling for Expressions of Interest to be invited to apply for the Monitoring Licence (Notice), amends the following parts of the Notice –

(1) **Introduction, Section 6.1** of the Notice (*Restrictions for the Licensee*) is amended as follows:

Listed on the Roll as a manufacturer of approved Gaming Machines or restricted components, supplier or tester of Gaming Machines or their Associates, subsidiaries or related bodies corporate (see www.vcgr.vic.gov.au for Roll of Suppliers)

With

A person who is listed on the Roll (as defined in the Act) who manufactures approved gaming machines or restricted components; supplies testing services; or does any of the things referred to in section 3.4.5(c), (d) or (e) of the Act; or an Associate, subsidiary or related body corporate of such a person or any other person who is otherwise prohibited or prevented by the Act (as it may be amended).

(2) **Part C, Section 12.1** of the Notice (*Lodgement Period*) is amended as follows:

Replace

‘The Lodgement Period will be restricted to:

10.00 to 14.00 (Australian Eastern Standard Time) on Friday 22nd May 2009’

With

‘The Lodgement Period will be restricted to:

10.00 to 14.00 (Australian Eastern Standard Time) on Friday 29th May 2009’
