### **A REVIEW OF VICTORIA'S ROAD SAFETY REGULATIONS FOR DRIVERS – CALL FOR PUBLIC COMMENT**

VicRoads is reviewing the road safety regulations.

The current Road Safety (Drivers) Regulations are due to expire in November 2009.

As a result VicRoads is required to review the regulations and update them to reflect the current road safety needs of Victorian road users.

VicRoads invites interested members of the public to comment on the proposed Road Safety (Drivers) Regulations.

These regulations set out the requirements for motorists when they apply for a licence or permit, the requirements for heavy truck and commercial bus drivers with regards to the number of hours they can drive, and the fees relating to driver licensing that motorists can be charged.

A Regulatory Impact Statement (RIS) has been prepared for the Drivers Regulations. The RIS includes information about the financial, economic and social impacts the proposed regulations are likely to have.
