Southern and Eastern Integrated Transport Authority Act 2003

ORDER DECLARING A PROJECT TO BE A ROAD TRANSPORT-RELATED PROJECT

I, Tim Pallas, Minister for Roads and Ports, pursuant to section 4A of the **Southern and Eastern Integrated Transport Authority Act 2003** make the following Order:

I declare that the Peninsula Link Project is a Road Transport-Related Project for the purposes of the **Southern and Eastern Integrated Transport Authority Act 2003**.

In this Order, 'Peninsula Link Project' means the project formerly known as the Frankston Bypass Project and now commonly known as the Peninsula Link Project, which includes, without limitation, the following elements:

- (a) the construction and operation of a transport corridor, and all related infrastructure, connecting the Mornington Peninsula Freeway and EastLink interchange at Carrum Downs to the Mornington Peninsula Freeway at Mt Martha;
- (b) the construction and operation of infrastructure, including the Lathams Road overpass and other road infrastructure, connecting the transport corridor and infrastructure described in paragraph (a) with existing or new transport infrastructure; and
- (c) the carrying out of any activities (including planning, obtaining permits and approvals, construction and operation activities) connected directly or indirectly with the matters described in paragraphs (a) and (b).
