### NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT (RIS)

#### Water (Resource Management) Amendment Regulations 2009

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Water (Resource Management) Amendment Regulations 2009.

The objectives of the proposed Regulations are to amend the Water (Resource Management) Regulations 2007 to –

- a) increase certain application fees relating to the transfer of ownership of a water share and the giving of a water allocation assignment; and
- b) remove the fee to correct or amend addresses recorded in the water register.

The RIS discusses possible alternatives to the proposed Regulations and concludes that the proposed Regulations are the best means of achieving the stated objective.
