## Essential Services Commission Act 2001

### NOTICE OF PRICE DETERMINATIONS

The Essential Services Commission (Commission) gives notice under section 35(2) of the **Essential Services Commission Act 2001** (Vic.) that it has, pursuant to sections 32 and 33 of the **Essential Services Commission Act 2001** (Vic.) and in accordance with clause 8 of the Water Industry Regulatory Order 2008 made under section 4D of the **Water Industry Act 1994** (Vic.), made determinations in respect of the prices which the following regulated entities may charge for prescribed services during the regulatory period, or the manner in which such prices are to be calculated or otherwise determined.

The determinations made by the Commission for the metropolitan retailers (City West Water Limited, South East Water Limited and Yarra Valley Water Limited) and Melbourne Water Corporation (with respect to bulk services) specify the prices which may be charged from 1 July 2009 to 30 June 2013 or the manner in which such prices are to be calculated or otherwise determined.

The nature and effect of each determination is to:

- (a) give effect to the decision made by the Commission in accordance with clause 8 of the Water Industry Regulatory Order 2003 on 24 June 2009;
- (b) specify the prices which the regulated entity may charge for prescribed services during the regulatory period or the manner in which such prices are to be calculated or otherwise determined;
- (c) facilitate the achievement of the Commission's objectives in the **Essential Services Commission Act 2001** (Vic.) and the **Water Industry Act 1994** (Vic.); and
- (d) reflect the requirements in the Water Industry Regulatory Order 2003.

The determinations take effect from 1 July 2009.
