- 31/2009 This Act comes into operation on the day on which it receives the Royal Assent.
32/2009 This Act comes into operation on the day on which it receives the Royal Assent.
33/2009 (1) This Act (except Part 2) comes into operation on the day after the day on which this Act receives the Royal Assent.
 (2) Subject to subsection (3), Part 2 comes into operation on a day to be proclaimed.
 (3) If Part 2 does not come into operation before 1 July 2009, it comes into operation on that day.
34/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
 (2) If a provision of this Act does not come into operation before 1 July 2009, it comes into operation on that day.
35/2009 (1) This Act (except sections 9, 10, 18 and 107 and Division 1 of Part 5 and sections 109 to 119) comes into operation on the day after the day on which it receives the Royal Assent.
 (2) Division 1 of Part 5 comes into operation on 1 January 2009.
 (3) Subject to subsection (5), sections 9, 10, 18 and 107 come into operation on a day or days to be proclaimed.
 (4) Subject to subsection (6), sections 109 to 119 come into operation on a day or days to be proclaimed.
 (5) If a provision referred to in subsection (3) does not come into operation before 1 December 2009, it comes into operation on that day.
 (6) If a provision referred to in subsection (4) does not come into operation before 31 December 2008, it comes into operation on that day.

-
- 36/2009 This Act comes into operation on the day on which it receives the Royal Assent.
- 37/2009 (1) This Act (except sections 8 and 9, Part 3 and Part 4) comes into operation on the day after the day on which it receives the Royal Assent.
(2) Sections 8 and 9 and Part 3 come into operation on 1 July 2009.
(3) Part 4 is deemed to have come into operation on 1 January 2006.
- 38/2009 (1) This Act (other than sections 3, 4, 5, 7, 8, 9 and 10) comes into operation on the day after the day on which it receives the Royal Assent.
(2) Subject to subsection (3), sections 3, 4, 5, 7, 8, 9 and 10 come into operation on a day to be proclaimed.
(3) If a provision referred to in subsection (2) does not come into operation before 1 July 2010, it comes into operation on that day.
