## Crown Land (Reserves) Act 1978

### ORDER GIVING APPROVAL TO GRANT OF A LEASE UNDER SECTIONS 17D AND 17DA

Under sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I, Gavin Jennings, MLC, Minister for Environment and Climate Change, being satisfied that there are special reasons which make the granting of a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease to Barwon Health by The Mint Incorporated as the Committee of Management, for the purpose of 'Office and business accommodation' over the Geelong Telegraph Station Reserve described in the Schedule below and, in accordance with section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that –

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

#### SCHEDULE

The land indicated by heavy black outline on the attached plan being Allotment 22B, Section 55A, City of Geelong, Parish of Corio, being the Crown land temporarily reserved for Conservation of a Historic Building by Order in Council of 31 October 1995 (vide Government Gazette of 2 November 1995 page 3077).
