Southern and Eastern Integrated Transport Authority Act 2003

ORDER DECLARING A PROJECT TO BE A ROAD TRANSPORT-RELATED PROJECT

I, Tim Pallas, Minister for Roads and Ports, pursuant to section 4A of the **Southern and Eastern Integrated Transport Authority Act 2003** make the following Order:

I declare that the WestLink Project is a Road Transport-Related Project for the purposes of the **Southern and Eastern Integrated Transport Authority Act 2003**.

In this Order, 'WestLink Project' means the project which includes, without limitation, the following elements:

- (a) the planning, construction and operation of a transport corridor, and all related infrastructure, broadly linking Dynon Road and Footscray Road in the Port of Melbourne precinct with Geelong Road and Sunshine Road in West Footscray.
- (b) the planning and construction of upgrades to Paramount, Dempster and Sunshine Road to provide an appropriate freight route, formerly known as Truck Action Plan Stage 2 and now part of the WestLink project.
- (c) the planning for a long-term transport corridor broadly linking Geelong and Sunshine Roads in West Footscray with the Western Ring Road.
- (d) the carrying out of any activities (including planning, obtaining permits and approvals, construction and operation activities) connected directly or indirectly with the matters described in paragraphs (a), (b) and (c).
