#### ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares or revokes the roads described in Schedule A and on the plans attached.

#### ROAD DISCONTINUATIONS

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the parts of the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 47 of the **Transport Act 1983** and as delegated by the Minister for Roads and Ports under section 32 of the latter said Act.

## SCHEDULE A

### FREEWAY

- a) Those parts of Tullamarine Freeway identified by hatching on the plan numbered GP21549 are declared or revoked as described in the legend in the said plan.
- b) That part of Tullamarine Freeway identified by hatching on the plan numbered GP21754 is revoked as described in the legend in the said plan.

### ARTERIAL ROAD

- c) That part of Melrose Drive identified by hatching on the plan numbered GP21549A is declared as described in the legend in the said plan.





- d) Those parts of Mascoma Street and Collier Court identified by hatching on the plan numbered GP21549B are declared as described in the legend in the said plan.

## SCHEDULE B


- a) Those parts of Tullamarine Freeway identified by hatching on the plan numbered GP21549 are discontinued as described in the legend in the said plan.


