

## Notice of Intention to Make Local Laws

Following a detailed review of its local laws, Corangamite Shire Council gives notice under section 119(2) of the **Local Government Act 1989** of its intention to revoke all three of its existing local laws and to replace them with three new local laws titled 'General Local Law 2009', 'Livestock Local Law 2009' and 'Processes of Municipal Government Local Law 2009'.

## **Purpose of the Local Laws**

The purpose of the local laws is to –

- introduce local laws that are user friendly, expressed in plain English, meet the requirements of the Council, the Corangamite community and the **Local Government Act 1989**, and comply with National Competition Policy;
- repeal all of the Council's existing local laws namely
  - Local Law No. 1, General Local Law 2004;
  - Local Law No. 2, Livestock Local Law 1999;
  - Local Law No. 3, Processes of Municipal Government Local Law 2005;
- provide for the peace, order and good government of the municipality;
- provide a safe and healthy environment so that the Corangamite community can enjoy a quality of life that meets its expectations;
- regulate the safe and fair use and enjoyment of public places;
- protect and enhance the amenity of the municipality;
- provide for the fair and reasonable use of private land;
- provide for the safe and orderly movement and droving of livestock through and within the municipal district;
- regulate the grazing of livestock within the municipal district;
- regulate the uniform and fair administration of the local laws;
- provide for the administration of Council powers and functions;
- regulate proceedings at Council meetings, Committee meetings and other meetings;
- regulate proceedings for the election of the Mayor and chairpersons of various committees;
- regulate the use of the common seal; and
- prohibit the unauthorised use of the common seal or any device resembling the common seal.

#### **General Purport of the Local Laws**

The local laws do the following –

Local Law No. 1: General Local Law 2009

- repeal all of the Council's existing local laws, being local laws numbers 1–3;
- require an owner or occupier of land to ensure that land is not dangerous, unsightly or detrimental to amenity;
- create an offence for a person to carry out specified open air burning without a permit;
- create an offence for a person to burn in an incinerator during the declared fire danger period;
- create an offence for a person to fail or refuse to extinguish a fire after being directed to do so by an authorised officer, member of the Victoria Police or member of a CFA brigade;

- create an offence of burning prohibited materials;
- create an offence for a person to burn longer than 12 consecutive hours between 1 November until the declared fire danger period without a permit;
- require an owner or occupier of land to ensure that a chimney is not used so as to constitute a danger to health;
- create an offence for a person, or an owner or occupier of land, to occupy or place (other than for storage purposes) a caravan or moveable dwelling on land for more than a specified period without a permit;

- create an offence to carry out specified trading activities on a road or Council land without a permit;

- create an offence for a person to drive or cause to be driven a vehicle on any Council

- create an offence for any person on Council land who fails to comply with any signs erected by the Council;
- create an offence for any person using Council land who behaves in any way that could cause harm or injury or which interferes with any other person's enjoyment of that land;
- create an offence for any person who disposes of domestic waste, organic waste or recyclable materials contrary to requirements of the waste collection service and the landfill operations;
- allow Council to impound any item that encroaches or obstructs the free use of Council land and to release those items to the owner on payment of a fee, or to sell, destroy or dispose of the item if the fee is not paid;
- empower an authorised officer to issue an infringement notice, give a direction or serve a notice to comply;
- allow a person to appeal to the Council for a review of specified matters under the local laws;



# AMENDMENT OF THE GENERAL EXEMPTION UNDER SECTION 8B TO POSSESS SWORDS

Order in Council

The Governor in Council under section 8B of the **Control of Weapons Act 1990** amends the general exemption to possess swords granted by Order in Council dated 16 June 2004 and published in the Government Gazette G25 on 17 June 2004, pages 1714–1717, as follows:

- the exemption at item 5 in the Table in the Order, which provides an exemption from the operation of section 5(1) of the Act to a member of a religion whose practices involve swords, is revoked; and
- the following provision is inserted in the Order immediately following the Table:

'The Governor in Council, under section 8B of the **Controls of Weapons Act 1990**, exempts from the operation of section 5(1) and section 5(1A) of the **Control of Weapons Act 1990**, in relation to Kirpans (swords), a person who is of a class of persons set out in an item in Column 1 of Table A below, to the extent specified opposite that item in Column 2 of Table A:

1	A Sikh whose religious practices require the carrying and possession of a Kirpan (a specific type of sword).
