Notice Declaring Certain Motor Vehicles to be High Powered Motor Vehicles

I, Don Hogben, Director – Vehicle Management and Safety, delegate of the Roads Corporation, make the following declaration under regulation 211(4)(a) of the Road Safety (Drivers) Regulations 1999.

1. Purpose

The purpose of this Notice is to declare certain motor vehicles to be high powered motor vehicles for the purpose of regulation 211A of the Road Safety (Drivers) Regulations 1999.

2. Authorising Provision

This declaration is made under regulation 211(4)(a) of the Road Safety (Drivers) Regulations 1999.

3. Revocation

The Notice declaring certain motor vehicles not to be high powered motor vehicles for the purpose of regulation 211A of the Road Safety (Drivers) Regulations 1999 published in Government Gazette S193 on 22 June 2009 is revoked.

4. Commencement

This Notice comes into operation on 21 August 2009.
