Determination Of Fees

I, Hector McKenzie, Director of Public Transport, Department of Infrastructure, pursuant to the provisions of section 147B of the **Transport Act 1983**, determine that the following fees shall apply from 1 September 2009 in respect of commercial passenger vehicle and private bus drivers' accreditations and commercial passenger vehicle licences other than the annual licence fees applicable to taxi-cab licences issued on or after 16 April 2003.
