Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Warren Chapman, Reserve Manager, Barwon Coast Committee of Management hereby:

1. Give notice under subsection 15(1) of the **Marine Act 1988** that;
 - (a) from 8.00 pm Friday 7 August 2009 till 5.00 pm 30 November 2010, bathing and the operation of vessels (including anchoring, mooring, drifting or allowing a vessel to lie), is prohibited on the waters of the Barwon River within the area detailed below in Table 1, (and indicated by yellow buoys in the water) except for those waters designated as a Transit Lane(s), delineated by red and green buoys.
 - (b) the operator, master or person in charge of a vessel must not use the Transit Lane(s) other than for transiting of the vessel and must not permit the vessel to be anchored, drift or moored in the Transit Lane(s).
 - (c) bathing is prohibited in the Transit Lane(s).

Table 1. Barwon River Exclusion Zone

The waters bounded by:

- (i) A line extending from a point on the shore located in the position 38°16' 2.56.22" S, 144° 29' 40.48" E to a point on the shore located in the 38° 16' 55.27" S, 144° 29' 52.03" E;
- (ii) A line extending from a point on the shore located in the position 38° 16' 55.27" S, 144° 29' 52.03" E to a point on the shore located in the 38° 16' 58.15" S, 144° 29' 51.24" E;
- (iii) A line extending from a point on the shore located in the position 38° 16' 58.15" S, 144° 29' 51.24" E to a point on the shore located in the 38° 16' 59.03" S, 144° 29' 40.44" E;
- (iv) A line extending from a point on the shore located in the position 38° 16' 59.03" S, 144° 29' 40.44" E; to a point on the shore located in the 38°16' 2.56.22" S, 144° 29' 40.48" E.
