### Authorisation A01285

Benalla Rural City Council has prepared Amendment C13 to the Benalla Planning Scheme.

In accordance with section 8A(3) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Benalla Rural City Council as Planning Authority to prepare the Amendment.

The land affected by the Amendment is the Lake Benalla area in the central section of the Benalla township.

The Amendment proposes to implement the Lake Benalla Environs Study, 2007 by including the study as a reference document to the scheme, including new strategic directions for land use and development in the lake environs in the Municipal Strategic Statement, including a new policy to guide applications for land use and development in the lake environs, applying the Design and Development Overlay to various sites around the lake, inserting Schedules 2 to 6 (inclusive) into the planning scheme and applying the Public Acquisition Overlay to three sites on the north-eastern side of the lake for public recreation purposes.

- (a) declare a Control Area for Enzootic Bovine Leukosis; and
- (b) specify the requirements which are to operate in the Control Area.

#### 3. Commencement

'Inspector' means an inspector of livestock appointed under the Act;

The whole of Victoria is declared to be a Control Area in respect of Enzootic Bovine Leukosis.

#### 6. Requirements in the Control Area

- (1) An owner of any cattle within the Control Area must if requested by an Inspector
  - (i) submit all cattle or milk for testing for Enzootic Bovine Leukosis, and identify the cattle, in accordance with any directions that may be issued by the Manager Animal Standards, to a registered veterinary practitioner, an Inspector or a person authorised by the Manager Animal Standards to test and sample cattle or milk for enzootic bovine leukosis; and
  - (ii) provide adequate facilities and sufficient assistance to allow the safe and efficient handling of cattle or milk during sampling and testing procedures required under paragraphs (i); and
  - (iii) provide requested information on the movement of cattle onto and from the owner's property to an Inspector.
- (2) In the case of cattle that are diagnosed as being infected with enzootic bovine leukosis, the owner of the infected cattle must
  - (i) immediately allow an inspector of livestock to apply an ear tag that identifies the cattle as an Enzootic Bovine Leukosis infected animal; and
  - (ii) provide adequate facilities and sufficient assistance to allow for an ear tag to be applied to the Enzootic Bovine Leukosis infected animal; and
  - (iii) dispose of the infected cattle by direct consignment to an abattoir or knackery within 30 days of application of the ear tag; and
  - (iv) notify the Manager Animal Standards of the identity of the animal disposed of, the method and location of disposal and, if requested, provide evidence of the disposal.
