## Subordinate Legislation Act 1994

### A REVIEW OF VICTORIA'S ROAD SAFETY REGULATIONS FOR TRAFFIC MANAGEMENT – CALL FOR PUBLIC COMMENT

VicRoads is remaking the road safety regulations.

The current Road Safety Regulations are due to expire in November 2009.

As a result VicRoads is required to review the regulations and update them to reflect the current road safety needs of Victorian road users.

VicRoads invites interested members of the public to comment on the proposed Road Safety (Traffic Management) Regulations.

The objectives of the regulations are to:

- regulate the installation, operation and maintenance of traffic control devices
- regulate particular on-road activities
- prescribe the requirements for traffic management plans as required by the **Road Safety Act 1986**.

A Regulatory Impact Statement (RIS) has been prepared for the Traffic Management Regulations.

The RIS includes information about the financial, economic and social impacts the proposed regulations are likely to have and concludes that the proposed regulations are the most appropriate means to achieve the objectives.
