- 53/2009 **Local Government Amendment (Conflicting Duties) Act 2009**

- 50/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision referred to in subsection (1) does not come into operation before 1 August 2010, it comes into operation on that day.
- 51/2009 (1) This Act comes into operation on the day after the day on which this Act receives the Royal Assent.
- 52/2009 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 1 September 2010, it comes into operation on that day.
- 53/2009 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
