Plant Health and Plant Products Act 1995

ORDER DECLARING A RESTRICTED AREA AT MILDURA FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Joe Helper, Minister for Agriculture, under section 20 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland Fruit Fly at Mildura, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

2. Authorising provisions

This Order is made under section 20 of the **Plant Health and Plant Products Act 1995**.

3. Definition

In this Order –

‘**accreditation program**’ means any program under which a person is permitted to issue an assurance certificate, including any procedures available under the Interstate Certification Assurance (ICA) Scheme;

‘**Act**’ means the **Plant Health and Plant Products Act 1995**;

‘**authorised person**’ means a person authorised by the Department of Primary Industries;

‘**inspector**’ means a person authorised as an inspector under the Act;

‘**Manager Plant Standards**’ means the person for the time being occupying or acting in the position of Manager, Plant Standards in the Department of Primary industries;

‘**Queensland Fruit Fly**’ means the exotic pest *Bactrocera tryoni* (Froggatt); and

‘**Queensland Fruit Fly host material**’ means any fruit or vegetable listed in Schedule 1.

4. Restricted area for the control of Queensland Fruit Fly

The restricted area for the control of Queensland Fruit Fly is declared to be the area described in Schedule 2.

5. Prohibitions, restrictions and requirements

- (1) The removal from the restricted area into any part of Victoria of any Queensland Fruit Fly host material is prohibited.
- (2) Subclause (1) does not apply if the Queensland Fruit Fly host material is –
 - (a) packed, labelled and certified in accordance with any conditions prescribed by an accreditation program, administered by the Department of Primary Industries; or
 - (b) accompanied by a plant health declaration issued by an authorised person declaring that the host material has been treated in a manner approved by the Manager Plant Standards; or
 - (c) accompanied by a plant health certificate issued by an inspector certifying that the host material has been treated in a manner approved by the Manager Plant Standards.

SPECIAL

- (3) The owners and occupiers of land described in Schedule 3 must give an inspector access to such land for the purposes of inspection, deployment of any lures or traps, application of any treatment or performance of any other actions which are necessary for the eradication or prevention of spread of the pest.
- (4) The owners and occupiers of land described in Schedule 3 must, on instruction from an inspector, strip Queensland Fruit Fly host materials from plants, collect and dispose of waste material, or treat the material in a manner approved by the Manager Plant Standards.

6. Verification of Consignments

Any Queensland Fruit Fly host material removed from the restricted area in accordance with clause 5(2), and the accompanying certificate or declaration, must be:

- (1) presented to an inspector for inspection; or
- (2) verified by a person accredited to do so by the Department of Primary Industries.

Schedule 2

The area of land bounded by a line commencing at the intersection of the Murray River and Pumps Road and proceeding in a westerly direction along Pumps Road to the intersection of Pumps Road and Cocklin Avenue, then in a northerly direction along Cocklin Avenue to the intersection of Cocklin Avenue and Fitzroy Avenue, then in a westerly direction along Fitzroy Avenue to the intersection of Fitzroy Avenue and Calder Highway and continuing in a westerly direction along Nardoo Street to the intersection of Nardoo Street and Coorong Avenue, then in a northerly direction along Coorong Avenue to the intersection of Coorong Avenue and Myall Street, then in

a westerly direction along Myall Street to the intersection of Myall Street and Boobook Avenue, then in a southerly direction along Boobook Avenue to the intersection of Boobook Avenue and Nealie Street, then in a westerly direction along Nealie Street to the intersection of Nealie Street and Dairtnunk Avenue, then in a northerly direction along Dairtnunk Avenue to the intersection of Dairtnunk Avenue and Myall Avenue, then in a westerly direction along Myall Avenue to the intersection of Myall Avenue and Boomerang Avenue, then in a northerly direction along Boomerang Avenue to the intersection of Boomerang Avenue and Twentieth Street, then in a north-westerly direction along Twentieth Street to the intersection of Twentieth Street and Twenty Third Street, then in a south-westerly direction along Twenty Third Street to the intersection of Twenty Third Street and Benetook Avenue, then in a northerly direction along Benetook Avenue to the intersection of Benetook Avenue and Twenty First Street, then in a north-westerly direction along Twenty First Street, which becomes White Cliff Avenue to the intersection of White Cliff Avenue and Walnut Avenue, then in a westerly direction along Walnut Avenue to the intersection of Walnut Avenue and River Avenue, then in a north-easterly direction along River Avenue to the intersection of River Avenue and McCarthy's Road, then in a north-westerly direction along McCarthy's Road to the intersection of McCarthy's Road and Paschendale Avenue, then in a northerly direction along Paschendale Avenue to the intersection of Paschendale Avenue and the Murray River and continuing in a generally easterly direction along the Murray River to the point of commencement.

Schedule 3

The area of land in Victoria within a radius of one and a half kilometres of the outbreak epicentre at 142.15782° East, 34.17389° South.

Note: Section 21 of the **Plant Health and Plant Products Act 1995** provides that a person is guilty of an offence and liable for a penalty not exceeding 50 penalty units in the case of a natural person, and 100 penalty units in the case of a body corporate for moving any host material from a restricted area contrary to any restrictions, unless authorised to do so by a permit issued by an Inspector.
