Marine Act 1988

SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Vin Wright, Acting Manager Operations, Bays and Maritime, Parks Victoria (the Waterway Manager for the Designated Port of Port Phillip), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. from 8.30 pm till 10.30 pm Tuesday 26 January 2010, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria, is prohibited within a 250 metre radius of a fireworks barge located at a point 250 metres east of the Mornington Pier Head; and
2. from 8.30 pm till 10.30 pm Tuesday 26 January 2010, bathing and the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels associated with the fireworks event and vessels owned and operated by Parks Victoria is prohibited within a 200 metre radius of a fireworks barge located at a point 200 metres from the east side from Rye Pier and 240 metres seaward from the Rye foreshore; and
3. at the completion of the events the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
