GREATER GEELONG PLANNING SCHEME  
Notice of Approval of Amendment  
Amendment C179

The Minister for Planning has approved Amendment C179 to the Greater Geelong Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment updates Clause 21.26, amends the schedule to the Rural Living Zone and the Farming Zone, amends Schedule 8 to the Development Plan Overlay, introduces Public Acquisition Overlay 3 to identify and reserve land for acquisition by VicRoads for the construction of the Geelong Ring Road Section 4B, removes Schedule 8 to the Development Plan Overlay from the land west of Anglesea Road, amends the Schedule to Clause 52.17 so that a permit is not required for native vegetation removal undertaken to accommodate the road and amends the Schedule to Clause 61.03.

The land affected by the Amendment is between Anglesea Road, Waurm Ponds and the Princes Highway West, Mount Duneed, through the Blue Circle Southern Cement Quarry.
