DECLARATION OF THE ABOLITION OF THE MID LODDON WATER SUPPLY PROTECTION AREA ORDER 2010

I, Tim Holding MP, Minister for Water, as Minister administering the **Water Act 1989**, make the following Order:

Citation

1. This Order is called the Declaration of the Abolition of the Mid Loddon Water Supply Protection Order 2010 (this Order).

Authorising provision

2. This Order is made under section 28 of the **Water Act 1989**.

Commencement

3. This Order takes effect on 21 January 2010.

Preliminary

4. The Mid Loddon Water Supply Protection Area was established by the Mid Loddon Water Supply Protection Declaration Order 2003. The Order commenced on publication in the Government Gazette on 20 May 2004. The Area was described in Plan No. LEGL./03-095 as lodged in the Central Plan Office of the Department of Sustainability and Environment. Local management rules have now been made that support the management of groundwater resources in the Mid Loddon Water Supply Protection Area. I consider that the preparation of a management plan for the Mid Loddon Water Supply Protection Area is now unnecessary and accordingly that there is no need for the Area to continue as a water supply protection area.

Declaration

5. I declare that the Mid Loddon Water Supply Protection Area is abolished.
