## Marine Act 1988

### SECTION 15 NOTICE

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Graeme Davis, Acting Manager Operations, Bays and Marine Parks Victoria (the Waterway Manager for the Designated Port of Western Port), hereby give notice under section 15(1) of the **Marine Act 1988** that:

1. for the times, dates and locations listed below, the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels operated by Parks Victoria and Life Saving Victoria associated with the Phillip Island Swim Classic and the Cowes Classic swim event, is prohibited on the following waters of the Designated Port of Western Port:
  - (a) Phillip Island Swim Classic swimming event between the hours of 12.01 pm and 1.00 pm Sunday 31 January 2010.  
The waters within 300 metres of the waters edge which lie to seaward from the edge of the water between two lines extending to seaward at right angles to the shore;
    - (i) one line extending from 50 metres east of the Anderson Street boat ramp, Cowes, and
    - (ii) one line extending from and along the eastern side of the Cowes Jetty Phillip Island.
    - (iii) Vessels involved in the Phillip Island Swim Classic swimming event are excluded from the requirements of Clause 2(a), 2(c) and 4b of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
    - (iv) Life Saving Victoria vessels and operators are excluded from the requirements of Sections 228 and 231 of the Marine Regulations 2009.
  - (b) Cowes Classic swimming event between the hours of 3.00 pm and 3.30 pm Saturday 13 February 2010.  
The waters within 300 metres of the waters edge which lie to seaward between two lines extending seaward at right angles to the shore;
    - (i) one line extending from Mussel Rock (approximately 300 metres West of Cowes Jetty), and
    - (ii) one line extending from the land beacon with a red triangular topmark on Erehwon Point, Phillip Island.
    - (iii) Vessels involved in the Phillip Island Swim Classic swimming event are excluded from the requirements of Clause 2 (a), 2 (c) and 4b of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
    - (iv) Life Saving Victoria vessels and operators are excluded from the requirements of Sections 228 and 231 of the Marine Regulations 2009.
2. at the completion of the events the waters will revert to the provisions of Schedule 5, contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

**Marine Act 1988****SECTION 15 NOTICE**

I, Diane Julie Bates, the Director of Marine Safety, on the recommendation of Graeme Davis, Acting Manager Operations, Bays and Marine Parks Victoria (the Waterway Manager for the Designated Port of Western Port), hereby give notice under section 15(1) of the **Marine Act 1988**, that:

1. from 11.45 am till 12.30 pm Saturday 31 January 2009 the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding vessels operated by Parks Victoria and Life Saving Victoria, associated with the San Remo Channel Challenge ocean swim event, are prohibited on the following waters of Western Port Bay:  
The waters which lie between –
  - (a) a line joining the Northern most point of the San Remo Jetty to the most south western point of the San Remo and Phillip Island road bridge, and
  - (b) a line directly below the overhead electricity power cables running approximately east and west over The Narrows between the township of San Remo and Newhaven.
  - (c) Vessels involved in the Phillip Island Swim Classic swimming event are excluded from the requirements of Clause 2(a), 2(c) and 4b of Notice No. 1 under section 15(2) of the **Marine Act 1988**.
  - (d) Life Saving Victoria vessels and operators are excluded from the requirements of Sections 228 and 231 of the Marine Regulations 2009.
2. at the completion of the event the waters will revert to the provisions of Schedule 5 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.

## SECTION 15 NOTICE

I, Diane Julie Bates the Director of Marine Safety, on the recommendation of Vin Wright, Manager Operations, Bays and Maritime Division, Parks Victoria (the Waterway Manager for the Yarra River upstream of the Designated Port of Port Phillip) hereby:

1. give notice under section 15(1) of the **Marine Act 1988**, that Notice 399/2009 (as published in the Victoria Government Gazette S385, 30 October 2009) is hereby to be revoked at 9.00 am Monday 1 February 2010; and
2. give notice under section 15(1) of the **Marine Act 1988** that from 9.00 am Monday 1 February 2010 till 5.00 pm till Friday 1 October 2010 the operation of vessels (including anchoring, mooring or allowing a vessel to lie), excluding those vessels involved with the Melbourne Main Sewer Replacement Project and those owned and operated by Parks Victoria is prohibited within the exclusion zone as detailed in Table 1.

**Table 1: Yarra River Exclusion Zone**

The waters bounded by:

- (i) a line extending from a point on the shore  $37^{\circ} 49' 23.3821''$  S,  $144^{\circ} 57' 00.9517''$  E to a buoy in the approximate position  $37^{\circ} 49' 25.2033''$  S,  $144^{\circ} 56' 59.5930''$  E;
- (ii) a line extending from a buoy in the approximate position  $37^{\circ} 49' 25.2033''$  S,  $144^{\circ} 56' 59.5930''$  E to a buoy in the approximate position  $37^{\circ} 49' 25.2862''$  S,  $144^{\circ} 56' 57.4579''$  E;
- (iii) a line extending from a buoy in the approximate position  $37^{\circ} 49' 25.2862''$  S,  $144^{\circ} 56' 57.4579''$  E to a buoy in the approximate position  $37^{\circ} 49' 25.0838''$  S,  $144^{\circ} 56' 55.6748''$  E;
- (iv) a line extending from a buoy in the approximate position  $37^{\circ} 49' 25.0838''$  S,  $144^{\circ} 56' 55.6748''$  E to buoy in the approximate position  $37^{\circ} 49' 24.2104''$  S,  $144^{\circ} 56' 49.9082''$  E;
- (v) a line extending from a buoy in the approximate position  $37^{\circ} 49' 24.2104''$  S,  $144^{\circ} 56' 49.9082''$  E to a point on the shore  $37^{\circ} 49' 21.9802''$  S,  $144^{\circ} 56' 49.4115''$  E; and
- (vi) from a point on the shore  $37^{\circ} 49' 21.9802''$  S,  $144^{\circ} 56' 49.4115''$  E thence along the northern side of the Yarra River shoreline to a point  $37^{\circ} 49' 23.3821''$  S,  $144^{\circ} 57' 00.9517''$  E.

3. at the completion of the works or as announced by Parks Victoria the waters will revert to the provisions of Schedule 3 contained in Notice No. 1 under section 15(2) of the **Marine Act 1988**.
